Discussions – Digital Assessment Tools

As presented by Simon Bates, Christina Hendricks, Eshana Bhangu and Georgia Yee.

In 2019, the cost of digital learning materials was discussed by this committee. A proposal was developed to limit these costs. The topic was brought forward to UBC Senate and endorsed as a topic of broad academic interest. In 2021, UBC Okanagan Senate passed Policy O-131.2 which started from the principles endorsed by UBC Vancouver Senate. It is now proposed that a \$65 CDN limit be put on the cost of these materials.

Internally, there is a philosophical perception that tuition covers the cost of instruction, and included in instruction is assessment. Quite often there are required digital learning materials and platforms whose cost is invariably passed along to students. These materials and platforms have been noted to enrich the experience of students.

Externally, we were informed by the experiences of institutions in other provinces. In Ontario in particular, there is a ministry directive that requires institutions to have a policy on this matter.

The UBC Student Affordability Taskforce is developing an "affordability plan" that the Board of Governors is heavily involved in. It was noted that the development of these principles into a policy is going to be a recommendation in that affordability plan.

It was noted that a policy is needed as principles do not have the same strength as policy. It was also noted that there are now prominent discussions about costs for students.

Discussion:

Discussion ensued about whether anything has changed since the principles were published and whether these are statistics available regarding how often the proposed \$65 CDN limit has been exceeded. It was noted that anecdotal experiences have been shared but statistical information is not readily available. It was further asked whether the dollar amount would be regularly changed as the price of materials increases.
