Integrative Teaching Evaluation Policy

Motion:

THAT THE Senate Teaching and Learning Committee strike a cross-campus working group with the attached membership and draft Terms of Reference.

As presented by Simon Bates.

The paper sets out the motivation to establish this cross-campus working group to formulate a more holistic policy on the evaluation of teaching, looking at diverse data sources. This is an area where the university has not had comprehensive policy. It was noted that this builds on recommendations that came out of the Students Evaluations of Teaching Working Group, that were approved by both Senates in May 2020. The faculty co-chairs of the working group, one from each campus, will move in lock-step to bring the group together in early 2022. They will then have an opportunity to review and make draft edits to the Terms of Reference, which would then be brought back to this committee for approval.

Discussion:

Discussion ensued regarding ways to better include groups that were perceived as being not addressed, such as graduate students, clinical students, TAs, professional programs, seminars, non-large lecture environments.

Learning and Teaching Beyond COVID

As presented by Simon Bates and Catherine Corrigall-Brown.

Potential opportunities exist for improving teaching and learning at UBC, in response to lessons learned during COVID-19, such as relating to teaching activities, implications for the design of courses, implications for flexible curriculum and program design, rethinking approaches to assessment, learning technology tools and teaching as a collaborative effort. Themes in response relate to innovation and flexibility, inclusion and well-being, and technology and support for faculty and student success, processes and policies. Moving forward, consultation will take place with strategic groups, faculty partners, students and administrative units. It was noted that there are many opportunities for future opportunities, including being able to re-watch lectures, prioritization and addressing gaps in teaching. Phase 2 consultation is ongoing with 30 meetings
