Revised Program: Master of Community and Regional Planning

THAT THE Senate Curriculum Committee approves the new courses, revised

courses and revised program as circulated.

The School of Community and Regional Planning (SCARP) has made significant revisions to the Master of Community and Regional Planning (MCRP) program and will be readmitting students soon. These proposals include significant restructuring and revisions to existing courses as well as some new courses. In regards to content connecting to the ISP, part of the restructuring includes changing what used to be a non-formal stream into a formalized concentration in Indigenous Community Planning. In this particular concentration, students will partner with an indigenous host community, making 5-8 trips to the community over the course of the practicum.

New Course: THFL 599

Graduate (2 of 2)

This proposal creates a place for students in theatre and film to undertake a production practicum after completing their Fine Arts program. Course credit is within the 3-6 credit range with no projects being approved under 3 credits.

New Program Option: Bachelor of Education > Rural and Remote Pathway

THAT THE Senate Curriculum Committee approves the new program option as circulated.

This program pathway is intended to be offered in a longer 24-month format and is also intended to create greater accessibility, by students in rural and

remote communities having local access to this teacher education program. Providing this local access is especially important as a number of teachers in rural communities do not have formal training, but have received a "letter of permission" from the Ministry of Education to teach due to the teacher shortage. This program is intended to appeal to those who already live in the rural and remote communities as well as future teachers.

Indigenous Strategic Plan (ISP)

Action 16 of the Indigenous Strategic Plan (ISP) states:

"Ensure all academic programs, undergraduate and graduate, include substantive content in at least one course which explores Indigenous histories and identifies how Indigenous issues intersect with the major field of study of the Faculty."

Discussion about ways to address the Indigenous Strategic Plan (ISP) in curriculum proposals has been ongoing. Implementing and communicating this imperative to proponents of curricula has been challenging. The ISP does not fall under the purview of UBC Senate, rather integrating its imperatives is the responsibility of all individual employees of the University.

Questions were raised as to whether curriculum proposals that do not satisfactorily address the ISP will be returned to its proponents and also what guidance should subcommittees offer if they receive proposals that do not address the ISP.

It was discussed how the committee saw its responsibility in this process. Discussion ensued about the possibility of the following solutions:

- Add content to the Guide to Curriculum Submissions that addresses best practices for integrating the ISP into curriculum proposals.
- Update the two-column curriculum proposal form to add a section or checkbox relating to whether the ISP has been addressed, such as a rationale section.
 - If a checkbox is used, what additional information would be needed in order to adequately assess proposals.
- Ask the Centre for Teaching, Learning and Technology (CTLT) or other UBC departments for guidance on implementing the ISP.
- Have facilitators guide the SCC through using the ISP Self-Assessment Tool.
- Invite Dr. Sheryl Lightfoot, Senior Advisor to the President on Indigenous Affairs; Canada Research Chair in Global Indigenous Rights and Politics; Associate Professor, First Nations and Indigenous Studies and Political Science to offer guidance on integrating the ISP.
