**Subject:** Candidates for Master of Science in Environmental Sciences

Senators will recall having accepted at the October 2007 Senate meeting a series of recommendations to determine an interim process for the granting of graduate degrees at UBC Okanagan. At the time of the October 2007 meeting, the Committee understood that the November 2007 candidates for graduate degrees would include candidates for the Master of Arts in Education, the Master of Education, and the Master of Science in Interdisciplinary Studies. Since that time, the list of candidates for degrees has been corrected such that it no longer includes candidates for the Master of Science in Interdisciplinary Studies, but it now includes one candidate for the Master of Science in Environmental Sciences.

The Committee therefore makes the following additional recommendations at this time:

- 1. The Faculty of Arts & Sciences has delegated to the College of Graduate Studies the responsibility of recommending a candidate for the Master of Science in Environmental Sciences to the Senate at its November 2007 meeting, and also the responsibility that the name of the College and the signature of the Dean of Graduate Studies, and not those of the Faculty of Arts & Sciences, will appear on the corresponding degree parchment.
- 2. The relevant recommendation to Senate at its November 2007 meeting will be through the following motion: "that the College of Graduate Studies, upon the request of and with the concurrence of the Faculty of Arts and Sciences, recommends to the Senate that the candidate for the degree of Master of Science in Environmental Sciences…"
- 3. It is recognized that the above actions are not to be construed as setting a practice or a precedent for future considerations and approvals relating to the awarding of graduate degrees at UBC Okanagan.

Committee with respect to an interim arrangement for the granting of the

Master of Science in Environmental Sciences at UBC Okanagan.

**Re:** UBC Okanagan Policy on Research Centres and Institutes

Date: 7 November 2007

At UBC there are no standard or simple, concise definitions of university academic institutes and centres. Given that only one institute and one centre currently exist at UBC Okanagan, it would make sense to implement policy defining academic institutes and centres and determining an appropriate approval process at this early date.

The Policies & Procedures Committee asked a working group to propose distinguishing characteristics for research centres and institutes and processes for their establishment, modification, and disestablishment. The working group consisted of Dr. Maurice Williams (Chair), Associate Vice-President Alaa Abd-El-Aziz, and Dr. Daniel Keyes. Following an initial discussion with the P&P Committee, and after consultation with both the DVC Executive Committee and Academic Council, that working group submitted its recommendations to the P&P Committee. The P&P Committee accepted the recommended policy and forwards it now to the Senate for approval.

### CHARACTERISTICS OF RESEARCH INSTITUTES AT UBC OKANAGAN

### A research institute

- Requires Senate approval to exist.
- Is not identified with a single faculty.
- Is intended to be permanent, i.e., intended to exist for more than three years.
- Generally involves external funding as well as the UBC Okanagan base operating budget and is normally allocated a budget.
- Houses paid administrative personnel, including a director.
- Adheres to standard university research policies.

- Is governed through a steering committee which shall include senior administrators as well as faculty and the institute director. There may also be a separate external advisory board.
- Submits annual reports to the Senate on activities. If the institute does not perform to the Senate's expectations three years in succession, Senate may vote to dismantle the institute.
- Does NOT offer undergraduate or graduate programs or degrees; undergraduate and graduate work is the purview of faculties, schools, colleges, and departments.
- May initiate, develop, and/or undergraduate and graduate courses in partnership with one or more faculties, schools, colleges, or departments.
- Participating faculty members are appointed to a Faculty, rather than to the Institute itself.

### DEVELOPMENT AND APPROVAL PROCEDURE FOR RESEARCH INSTITUTES

- 1. Proposal initiated by faculty, Dean, or other university personnel.
- 2. Preliminary plan submitted to Associate Vice-President, Academic & Research.
- 3. Associate Vice-President, Academic & Research establishes a committee to develop a full proposal and informs Okanagan Senate Learning and Research Committee.
- 4. The full proposal, including a business plan, the structure, procedures, plans for a review following a specified period of operation, and an indication that the institute will be fully viable within three to five years, submitted to Senate Learning & Research Committee. The Learning & Research Committee ensures the academic credibility of institutes.
- 5. Learning & Research Committee reports to Senate with a recommendation.
- 6. Senate consideration for approval.
- 7. Senate recommends approval by the Board of Governors.
- 8. Once approved, the proposal returns to the Associate Vice-President, Academic & Research for implementation oversight.

### CHARACTERISTICS OF RESEARCH CENTRES AT UBC OKANAGAN

### A research centre

- Is intended to exist for a limited period of time, i.e., is transitory.
- Has a project-based mandate; often associated with an internal or external grant.
- Benefits from single or multi-faculty involvement.
- Adheres to standard university research policies.
- Submits annual reports to Associate Vice-President, Academic & Research, with copies to the appropriate unit head, Dean and/or senior administrator.
- Does NOT offer undergraduate or graduate programs, courses, or degrees; undergraduate and graduate work is the purview of faculties, schools, colleges, and departments.

### DEVELOPMENT AND APPROVAL PROCEDURE FOR RESEARCH CENTRES

- 1. Established through unit heads, Deans and/or Directors after approval by Associate Vice-President, Academic & Research; centres are not established by or within an institute.
- 2. The Associate Vice-President, Academic & Research will report for information the establishment of a centre to Senate, but it does not require Senate approval. When a centre is dismantled, the Associate Vice-President, Academic & Research will also report that to Senate for information.

### **Applicability Note**

The policy is intended to apply to all UBC Okanagan research centres and institutes established in future. Centres and institutes that were established prior to the creation of this policy, may wish to consider proposing (and submitting for approval as appropriate) certain adjustments, e.g., to their names, to bring existing units in line with the new policy.

**Motion:** That the policy on Research Centres and Institutes, as recommended by the Policies &

Procedures Committee, be approved.

**Subject:** Process for Review of Academic Organization of Faculties and Units

at UBC Okanagan (information)

### **Context for Review**

UBC Okanagan is now into its third year of operation. Conceived as complementary to, yet different from UBC Vancouver, UBC Okanagan's mission emphasizes an interdisciplinary academy, excellence in teaching and research, a focus on the learner, and promotion of local and global communities. After the initial two-year formative period, the Committee suggests that it is timely during this period of rapid growth to review the current academic organizational structure to assess effectiveness toward the achievement of the goals set out in the UBC Okanagan academic plan. Any review postponed to the four or five year mark would likely be problematic as it would attenuate around 2011 when, due to campus growth and progress, consideration of changes to structures will be harder to implement.

It is important to note that this proposal is to review the units which house programs, rather than to review the programs themselves. As a result of such a review, UBC Okanagan might affirm the preliminary organizational structure selected during the transition period and/or identify areas for modification and improvement so that this campus continues to grow and meet its potential.

Some questions already identified that support the need for review:

- 1. Should there be one Bachelor of Arts degree? Each Faculty is normally responsible for its own degrees, yet we have some common requirements for Bachelors of Arts offered by two different faculties.
- 2. What is the optimal relationship between graduate studies and the Faculties?<sup>1</sup>

<sup>1</sup> The Committee is aware that another task force has been charged with answering this and related questions, but feels that this issue is worthy of note here too.

3. What is the optimal academic organizational structure among and within Faculties to ensure that programs thrive? Is it possible, for example, for one unit within a Faculty to support five to seven different programs?

### **Mechanism for Review**

The Committee has invited the Associate Vice-President, Academic & Research to strike and chair a task force to conduct a review of the academic organization of the Faculties of Arts & Sciences, Creative & Critical Studies, Health & Social Development, and Education<sup>2</sup>

### **Task Force Composition**

In consultation with the Associate Vice-President, Academic & Research, and in reflection of the relative size and complexity of each faculty, the composition of the 11-member task force will be as follows:

Associate Vice-President, Academic & Research (Chair)
Faculty of Arts & Sciences (3 faculty representatives)
Faculty of Creative & Critical Studies (2 faculty representatives)
Faculty of Health & Social Development (2 faculty representatives)
Faculty of Education (1 faculty representative)
1 undergraduate student
1 graduate student

Members will be invited to serve by the Associate Vice-President, Academic & Research, following appropriate consultation. The Assistant Registrar, Senate & Curriculum Services (or delegate) will serve as process advisor to the task force.

### **Reporting Process and Timeline**

The task force is invited to deliver a report to the Policies & Procedures Committee by March 31, 2008. The task force may wish to consult the Academic Council and others as appropriate. Depending on the recommendations of the task force, other Committees of Senate may need to be consulted or grant approvals. Following the appropriate consultations and/or approvals at the Senate Committee level, a report is expected to be presented to the Senate for approval no later than the May 2008 meeting.

### **Issues for Consideration**

- 1. The relative size of each Faculty;
- 2. The disciplines within each Faculty;
- 3. The name of each Faculty;
- 4. The academic unit structure, if applicable, within each Faculty;
- 5. Can any identified issues be properly addressed within the current structure?

### **Report from the Vancouver Senate Agenda Committee**

We are pleased to provide to the Senates, for information, the following update regarding the operation of the Senate Secretariat.

### **Secretariat Budget**

In order to conduct the business of the Senates, the Secretariat has in previous years been reliant on one-time funding transfers from a variety of units. Each time a new service was requested or an event planned, the Secretariat found itself in the uncomfortable position of requesting a subsidy of some sort. Accordingly, a request was made for the development of a distinct operations budget for the secretariat activities of the Vancouver Senate, the Okanagan Senate, and the Council of Senates. We note that the Secretariat also administers triennial elections for the Chancellor and faculty, staff, convocation, and student representatives to the Board of Governors and the Senates. We are pleased to advise the Senates that the Secretariat budget has been suitably increased on an annualized basis, such that current core activities at both campuses are appropriately funded.

### **Associate Secretary**

Following a recommendation of the Vancouver Senate Agenda Committee, the President as Chair of the Senates and the Register as Secretary of the Senates have assigned the title of Associate Secretary of Senate to be used in addition to, or as an alternate to, that of the Assistant Registrar, Senate & Curriculum Services. This recommendation arises because of the extensive role of the incumbent (Ms. Lisa Collins) with respect to the Senate Secretariat, particularly through duties that are closely aligned to those of the Secretary of the Senates; and the need for frequent references to Ms. Collins' position by a title that suitably reflects these aspects of her portfolio.

The Committee is grateful to President Stephen Toope, Chair of the Senates, and to Brian Silzer, Secretary of the Senates, for their support for the enhancements indicated above.

**Type of Action:** Update current reference to IB transfer credit to allow for IB transfer credit to be granted for Standard Level (SL) courses, not just Higher Level (HL) courses.

**Rationale:** UBC currently provides transfer credit for IB Higher Level courses based on reviews of IB course outlines conducted by UBC faculties and departments. Opportunities for transfer credit based on IB Standard Level courses may also exist however SL courses have never been formally reviewed by UBC faculties and departments. Some faculties are now beginning to look at the content, scope, and rigor of IB Standard Level courses. The Faculty of Science is likely to recommend credit for SL Physics in the near future. Should a faculty determine that transfer credit is appropriate for IB SL courses, the Calendar statement below should accommodate this possibility.
