Calendar statement on admission to undergraduate programs requiring prior study

section of the Calendar:

Admission requirements for undergraduate programs requiring either substantial progress towards or completion of a prior degree are specified in Calendar entries for the Faculties and Schools offering these programs. Applicants are advised that in some cases a recognized prior degree may not satisfy requirements for specific pre-admission studies.

(Third paragraph) The required prerequisite subjects are: Biology 120 (3 credits); Biology 110 (3 credits), or Biology 115 (3 credits), or Biology 12 with a grade of 80% or better; Chemistry 110 (6 credits), or Chemistry 121 (3 credits) and Chemistry 122 (3 credits); six credits of first year English; Mathematics 100 (3 credits) and Mathematics 101 (3 credits); six credits of first year university Physics with a laboratory. Students who have completed Science One, including six credits of English, are eligible to apply.

Faculty of Education - clarification of Faculty authority to terminate a practicum The committee recommended approval of the following change in the Calendar statement concerning the authority of the Faculty of Education to terminate a practicum:

Candidates who begin the Extended Practicum (Education 329, 418, 495, or 496) are not permitted to drop this course from their records. When, in the judgment of the Faculty of Education or the schools hosting their practica, students do not complete their practica satisfactorily, and who qualify for neither a supplemental practicum (see Supplemental Examinations) nor a deferred practicum (see "Deferred Examinations" in the General Information section) will be assigned a failing grade and will be required to discontinue or to withdraw from the program.

Dr. Kirkness suggested that the words "ŠFaculty of Education or the schoolsŠ" should read "ŠFaculty of Education and the schoolsŠ". Dean Sheehan agreed with the suggestion, stating that when a student is withdrawn from a practicum it is a decision made in concert with the principal of the school, the cooperating teacher and the faculty involved with the student.

The motion, with the change noted, was put and carried.

Faculty of Education - admission requirements for the Preparation Program for Career Education Teachers

The committee recommended approval of the following admission requirements for the Preparation Program for Career Education Teachers:

Reports OF COMMITTEES OF SENATE

(a) Admission Requirements and Prerequisites

Applicants seeking admission to UBC as a candidate in the Program of Initial Teacher Education (Secondary) (Career Education) must have completed:

- i. Interprovincial Trades Qualification "Red Seal" (Cook) or equivalent.
- ii. A minimum of 30 credits of arts and science university transfer courses, including 6 credits of English composition and literature and 6 credits of mathematics and/or laboratory science.

Arts and Science Courses: Students in this program may complete their arts and science courses at various institutions. University courses (including university transfer courses) may be completed at other post-secondary institutions (colleges or universities) either through face-to-face instruction or through distance education means. Consistent with practice for other teacher education programs, such courses will not be formally transferred to UBC and students will not receive a B.A. or B.Sc. degree from UBC.

Students are strongly encouraged to develop second teaching subjects by fulfilling the requirements fro those subjects as set out under "Secondary Teaching Field Requirements" in the Faculty of Education section of the Calendar.

(b) Courses required to implement the program:

EPSE 306, 317, 311, EDUC 3XX, 496, 316, ENED 426, EDST 314, BUED 410, EDUC 412, CNPS 427, EPSE 423, EDST 42X, EDUC 420, YY- 314, EDUC 496 (total credits 61)

Students may not depart from the sequence of courses specified for the program. Students who do not maintain a cumulative average of 65% will be required to withdraw from the program.

- (c) Program Sequence
 - a. First Summer Program (11 credits)
 - b. Second Summer Program (10 credits)

- c. Winter following Second Summer (9 credits) (This practicum will normally be completed on an internship basis by those in regular employ as teachers in the Career Preparation program in B.C. Secondary schools. The internship will be in this teaching field only.)
- d. Third Summer Program (13 credits) (Candidates who have completed all of the above (a-d) are eligible for the B.C. Developmental Standard Teaching Certificate issued by the B.C. College of Teachers.)
- e. Fourth Summer Session (12 Credits)
- f. Completed on Personal Schedule: Arts or Science courses required for second teaching subject, or taken as electives (18-21 credits) (A minimum of 18 such credits must be upper level courses) (Candidates who complete the above additional requirements (e and f) are eligible to apply for a regular Standard Teaching Certificate issued by the B.C. College of Teachers.)
- g. Completed on Personal Schedule

(This practicum will normally be completed on an internship basis by those in regular employ as teachers in the Career Preparation program in B.C. Secondary schools. The internship will be in both this teaching field and in the individual's selected second teaching subject. To qualify for such an internship, the individual must be teaching at least one-third of a full time-table in this second subject and must have classes in this subject at two or more grade levels.)

Credits needed to fulfill requirements for B.Ed. (Secondary) 21. (Candidates who complete this full program (a-g) are eligible to apply for the B.Ed. (Secondary) and for the B.C. Professional Teaching Certificate.)

Faculty of Graduate Studies

The committee recommended approval of the following admission requirements for the Electro-Mechanical Design Engineering program leading to the degrees B.A.Sc. and M.Eng. in Mechanical Engineering:

Students with a high academic standing and demonstrated interest in design will be selected by interview from the second year class. Students will be required to have and to maintain a cumulative grade average of 74%. In addition, a grade of 60% must be obtained in every course in which the student is involved. In all but six credits of course work in each year a student must obtain at least 68%. Thus, the students will be required to have and to maintain grades required by the Faculty of Graduate Studies for graduate students. Students who do not maintain an adequate average will be required to return to the regular Bachelor of Mechanical Engineering program.

Dr. Will Dean Meisen That the admission requirements for the Electro-Mechanical Design Engineering program leading to the degrees B.A.Sc. and M.Eng. in Mechanical Engineering be approved.

Faculty of Commerce and Business Administration

The committee recommended approval of curriculum proposals from the Faculty of Commerce and Business Administration, subject to the deletion of COMM 341 as a prerequisite for COMM 441.

Faculty of Dentistry

The committee recommended approval of curriculum proposals from the Faculty of Dentistry, subject to editorial changes to the description of CDSC 404.

Faculty of Education

The committee recommended approval of a proposal to delete EADM 460. The committee also recommended approval of a Preparation Program for Career Education Teachers.

Faculty of Forestry

The committee recommended approval of curriculum proposals from the Faculty of Forestry, subject to editorial changes to the description of FRST 202.

Faculty of Graduate Studies

The committee recommended approval of curriculum proposals from the Faculty of Graduate Studies, subject to the following:

INDS 502 delete course description and change title to read: Interfaculty Themes: Seminars, lectures and discussions involving two or more Faculties.

OCCH 507 delete course description

HCEP 521 add credit designation (3)

PATH 541 vector designation should read [1-2-0, 1-2-0]

PATH 542 vector designation should read [0-6-1, 0-0-0]

In addition to the course proposals, the committee recommended approval of a proposal that the name of the Ph.D. degree program be changed from "Ph.D. in Social Foundations of Educational Policy" to "Ph.D. in Educational Studies."

The committee also recommended approval of the Electro-Mechanical Design Engineering Program, leading to the degrees B.A.Sc. and M.Eng. in Mechanical Engineering. Dr. Berger noted that approval of ELEC 283 (2) Electro-Mechanical Laboratory I and ELEC 383 (2) Electro-Mechanical Laboratory II had been withheld at the May meeting of Senate, pending approval of the program. The committee recommended approval of these courses.

School of Human Kinetics

The committee recommended approval of curriculum proposals from the School of Human Kinetics, subject to editorial changes.

Faculty of Medicine

The committee recommended approval of curriculum proposals from the Faculty of Medicine.

With the exception of proposed changes to GEOL 405, which were withdrawn, the committee recommended approval of curriculum proposals from the Faculty of Science, subject to editorial changes. Dr. Berger noted that a proposed change under the heading "English requirement" had been dealt with by the Senate Admissions Committee, and that the Admissions committee would be reporting on this item at the January meeting of Senate.

In response to a query by Dr. Grace concerning the committee's recommendation that the title of INDS 502 be changed from Interdisciplinary Themes to <u>Interfaculty Themes:</u> <u>Seminars, lectures and discussions involving two or more Faculties</u>, it was confirmed that the themes will be interdisciplinary.

The motion was put and carried.

AD HOC COMMITTEE ON UNIVERSITY ORGANIZATION

Dr. Shearer, chair of the committee, explained that copies of the second report of the committee had been distributed at the meeting to allow members of Senate time to study the recommendations prior to discussion at the January meeting.

Dr. Shearer reported that the committee had begun consultations on the administrative organization of studies in human health at UBC, and, also, that it has plans to begin a review of the nature and role of the Faculty of Graduate Studies in January.

Faculty of Applied Science

HONOURS STANDING - REVISED CALENDAR STATEMENT

It was stated in the material circulated that, in order to avoid confusion with the new Dean's Honours List, the term "with Distinction" was preferable to the current "with Honours". The proposed Calendar entry will read: "On graduation students will be granted a degree "with distinction" if they obtain an averageŠ".

Faculty of Arts

REORGANIZATION OF DEPARTMENTS

The following proposal had been circulated:

- 1. That the Department of Russian and Slavic Languages and Literatures be dissolved as of June 30, 1995.
- 2. That the separate Departments of Classics and Religious Studies be dissolved as of June 30, 1995, and that a combined Department of Classical, Near Eastern and Religious Studies (CNRS) be established as of July 1, 1995, to include all members of the previous two departments of Classics and Religious Studies, as well as all courses and programs of both departments.

Dean Marchak	1	That the Department of Russian and Slavic
Dr. Grace	}	Languages and Literatures be dissolved as of June 30, 1995.

In speaking to the motion, Dean Marchak explained that the Russian language courses were being maintained, and noted that there had been an increase in the number of students taking Russian courses at the 100 and 200 level. The Dean also informed Senate that the Faculty would be maintaining a minor in Russian language. In response to a query, the Dean confirmed that there had been no terminations and that the faculty members concerned had been assigned to other departments.

The motion was put and carried.

Dean Marchak Dr. Grace	}	That the separate Departments of Classics and Religious Studies be dissolved as of June 30, 1995, and that a combined Department of Classical, Near Eastern and Religious Studies (CNRS) be established as of July 1, 1995, to include all members of the previous two departments of Classics and Religious Studies, as well as all courses and programs of both departments.

Dean Marchak explained that the merging of these two departments was underway before Senate's restructuring proposals were approved; the reasons being that both departments are small and that there is considerable interaction between them in terms of research and shared courses.

The motion was put and carried.

The W. Maurice Young Entrepreneurship and Venture Capital Research Centre

A proposal that the Entrepreneurship and Venture Capital Research Centre be named "The W. Maurice Young Entrepreneurship and Venture Capital Research Centre" had been circulated. It was explained in the material circulated that Maurice Young's contributions to the Centre go well beyond his extremely generous and continuing financial support. His financial sponsorship allowed the Centre to commence its activities with the comforting knowledge that there was ample funding for at least four years of operation. This certainty of funding allowed the Centre to develop both longer term and shorter term research plans, and in the process map out a comprehensive approach to research, policy and community outreach. Moreover, his financial backing and his ability to obtain for the Centre strong links to and support from the business community, were key elements in the Centre's receiving the \$2.125 million Major Collaborative Research Grant from SSHRCC.

It was felt that Maurice Young's diverse and fundamental contributions to the Entrepreneurship and Venture Capital Research Centre should be recognized through naming the Centre "The W. Maurice Young Entrepreneurship and Venture Capital Research Centre".

}

Dr. Birch Dean Goldberg That Senate approve the recommendation that the Entrepreneurship and Venture Capital Research Centre be named "The W. Maurice Young Entrepreneurship and Venture Capital Research Centre".

Carried.

Disestablishment of the Chair in Audiology and Speech Sciences

It was explained in the material circulated that Senate approved the establishment of the Chair at its meetings of December 11, 1991 and September 16, 1992. At the time the Chair was approved, \$204,000 (including provincial match) had been raised for the endowment. It is now thought to be unlikely that the minimum \$1,000,000 necessary to support a Chair will be raised. The expectation is that \$700,000 will be raised and the income from that endowment will be used to support a Professorship rather than a Chair.

Calendar - Exchange Student Category

Senate was informed that in order to reflect the approval of Canadian student exchange programs and the approval of exchange programs in the Faculty of Commerce and Business Administration, the definition of the "Exchange" category will be changed to: "Exchange: a visiting student studying at The University of British Columbia under a Senate approved student exchange program and enrolled in studies for transfer to a degree program at another university."

Academic Year 1995-96

A draft of the section of the Academic Year for inclusion in the Calendar had been circulated for information.

Other Business

READING BREAK

Dr. Williams referred to the concern expressed by the Board of Governors that the examination schedule might extend into May, and the motion moved at the previous

meeting that this matter be referred to the Senate Committee on Academic Policy for further examination. Dr. Williams stated that the Registrar's Office had looked at this problem whether or not the examination period extends into May depends upon the date on which we being the second and the time at which Easter occurs. The next time this poses a problem is in the year 2002. The committee did not propose to make any changes to the policies to accommodate such a future occurrence.

For the benefit of those not familiar with the extent to which the committee had examined this problem, Dr. Williams stated that in the previous Senate the committee had looked at the examination periods in the two terms and had brought a motion to the first meeting of the current Senate recommending that the lecture and examination period for each term be equal. At the same time, documentation had been circulated on a selected group of Canadian universities for a particular year, chosen at random. Within that group there were three universities, Toronto, Queen's and Concordia, whose examination schedules for the year chosen extended into May. It did not appear to be a problem for them. Subsequently, a subcommittee of the Academic Policy Committee was established which made two recommendations basically giving Senate a choice; the consequences of both recommendations being made clear at the time they were brought to Senate. Senate therefore made its decision based on the information presented. Dr. Williams suggested that the alternatives for the particular years that pose a problem, such as abolishing the week-long break, to shorten the length of the lecture period, or to shorten the length of the examination period which had recently been shortened for the first time, were not academically sound options. Dr. Williams stated

ELECTRO-MECHANICAL DESIGN ENGINEERING PROGRAM (B.A.SC. AND M.ENG.)

Referring to the Electro-Mechanical Design Engineering Program, dealt with in the report of the Curriculum Committee, President Strangway observed that this was the first combined five year Bachelor's/Master's program.

Dean Meisen noted that this was the first program of this type in Canada. He stated that in some of the professional disciplines there is so much pressure on the programs that it could eventually lead to the Master's degree being the first professional degree rather than the baccalaureate degree. He noted that the number of credits that make up a particular degree in engineering, for example, far outweigh the typical number of credits in many of the standard four-year programs. The Dean said that, in some sense, this was an experiment which was well justified given the requirements of the market place for students. He stated that he would inform Senate, periodically, on the progress of this venture.

Adjournment

The meeting adjourned at 8.45 p.m.
