Discussions

V-129: *Non-Credit* As presented by S. Bates and J. Iverson: *Credentials*

J. Iverson provided an overview and the context for the proposed policy V-129.

- S. Bates continued with the overview, by connecting the proposed proposal to the recently approved Senate policies V-127 and V-128, and also work that has happened with the Board of Governors and other stakeholders.
- J. Iverson noted the success of a similar policy at UBC Okanagan. She also provided additional details regarding how the policy will be operationalized.
- S. Matsui asked for additional details regarding the status of learners who will be enrolled in these programs and also how hours of study and program requirements will work.

In response, J. Iverson explained the difference between students and learners, according to the University Act. S. Bates provided information about non-credit hours of study.

S. Singh asked for information about how UBC policies and resources will apply and be available to learners and lecturers, particularly when non-credit courses are in-person.

In response, S. Bates confirmed that the policies referenced by S. Singh would apply to students, not learners. He provided details about why the policies would not necessarily be as relevant to learners. He also provided additional information about lecturers and resources relating to them. E. Salzberg provided examples from her faculty that were relevant to the response provided by S. Bates.

- S. Jarvis-Selinger spoke in support of the proposed policy. She provided suggestions regarding specific changes to language in the policy.
- J. Iverson asked that S. Jarvis-Selinger and any other members send their feedback by email. J. Iverson will revise the policy based on the feedback, and share it with the Certificate and Diplomas Working Group. Once the Working Group has reviewed the revisions, she will share it with the Committee.
